- Overview of IRWM Program
 - o Lindsey provided overview of the IRWM Program in California and IRWM Plans
- East Stanislaus Region
 - o Lindsey provided overview of the East Stan IRWM Region including its boundaries, how it was formed and by whom, and when the first IRWMP was completed
- IRWMP Update Overview
 - Patrick Question: Question regarding roles and governance structure for the region.
 See info in governance section of presentation. Essentially, the ESRWMP, the Regional Water Management Group for the Region, is the top of the group (cities and county elected officials/policy representatives) supported by Steering Committee (cities and county staff) and Public Advisory Committee (open to public, other stakeholders and interested parties)
 - Patrick Question: What projects have been funded in the region so far?
 - Two projects funded under 2015 IRWM implementation grant:
 - 1.North Valley Regional Recycled Water Program a regional recycled water project being implemented by the Cities of Modesto, Ceres, and Turlock and Del Puerto Water District (located in the Westside-San Joaquin IRWM Region) providing recycled water for agricultural water supply reliability and in-lieu recharge
 - 2.Modesto urban flooding and groundwater recharge project added low impact development and gravity pipe infrastructure to move floodwater

out of disadvantaged area, rehab to park, and provide groundwater recharge

• Governance and Public Involvement

- Steering Committee members are welcome to attend PAC meetings, though they are not required.
- O As of the meeting date, there were no official PAC members. That was the purpose of this meeting – to solicit participation and start the process of identifying PAC members. As the ESIRWMP Update Stakeholder Contact List is further updated, during DAC focused outreach including phone calls and face-to-face meetings, and during the August public workshop, additional PAC participation will be sought and additional members may be added.
- Kevin: For the Eastside Water District and Eastside JPA would be on the PAC and would likely provide a letter of support after the IRWMP Update is finalized
- o Abigail Question: In terms of those that have been reached out to: has there been any effort to reach out to DACs and what is the plan to do so? Response:
 - The project team is in the process of updating and identifying DACs and finding appropriate DAC contacts for direct outreach
 - Monterey Park tract has previously been involved as a DAC participant
 - Waterford, Modesto, and other DACs are also included on the Steering Committee
 - Jim (from Modesto): has a list of contacts that he has reached out to, but not sure if all the information is up-to-date (didn't get any emails bounced back). Jim will add Abigail to PAC contact list
 - Abigail will review DAC contact list included in the Stakeholder Contact
 List spreadsheet and add to it if she has additional information

Next Steps

- o For PAC membership: Request one representative and one alternate, if feasible, to represent agency/organization/group to assist in continuity by ensuring a representative from each PAC member agency attends every meeting
- Kevin: Happy to review draft deliverables and wanted to make sure he gets emailed.
 Requests to be PAC member for the two agencies that he represents
- o Abigail: Self-Help Enterprises is interested in being a PAC member. She will confirm who the representative and alternate will be.
- O Patrick: Interested in being a PAC member for Tuolumne River Trust communication dropped off in earlier process, would like to be kept in the loop through project submittal and selection process. (Note: Patrick out-of-town the last two weeks of July). Patrick had a question about how projects are selected for grant applications under the IRWM Plan. Response:
 - Process is outlined in the IRWM Plan and is being updated. The Project Selection Process is agreed upon by the Steering Committee and PAC and projects on the Plan's project list are scored based on the agreed scoring criteria. A consensus-based approach is then used for identifying projects from the Project List to include in the grant application which will result in a competitive application to increase chances of success.
