1. Purpose of Meeting

- Finalize vision, goals, and objectives
- Develop project prioritization methodology
- Identify next steps and action items

2. Discussion Summary

- Leslie reviewed the PowerPoint presentation covering the following.
 - Vision, Goals, and Objectives
 - Leslie reviewed proposed changes to goals and objectives based on RMC recommendations and feedback from the PAC and SC after the June 2017 meetings.
 - Jim asked how we address unimpaired flows. Leslie responded that it could be added to the water supply goal, the environmental protection goal, and economic and social responsibility goal. Modify objective in Water Supply goal to say "Protect existing water rights and permitted diversions."
 - In the Environmental Protection goal, modify the last objective to say "Promote the recovery and stability of regionally present of native species and populations."
 - In Regional Communication goal "Implement focused outreach to DACs and EDAs relative to opportunities for water supply, water quality, flood management, and environmental protection projects."
 - In the Economic and Social Responsibility goal, add "and EDAs" after "disadvantaged communities" in the first objective.
 - SC approved goals and objectives with the changes above.
 - Project Prioritization
 - Leslie reviewed the project prioritization method used for the 2013 IRWMP.
 - Jim commented that the major issues within the Region seem to be water supply and water quality.
 - The SC agrees to apply the same prioritization methodology used in 2013 with the following proposed adjustments to the weights.

 - RMC to revise Project Solicitation Form and OPTI in preparation of Project Solicitation Period. It is tentatively scheduled for August 1st through September 15th, providing over a month for agencies and stakeholders to identify projects they wish to submit, gather project information, and complete the online form in OPTI.
 - RMC to prepare for August Public Workshop (8/15 from 5:30pm to 7:30pm). Jim to include an announcement on the website. RMC to provide SC members flyers and newspaper announcement for the workshop.
